

MEMORANDUM OF COOPERATION
between

**The Central-European Academy of Training and Certification
(CEASC), Bydgoszcz, Poland**

and

Pylyp Orlyk International Classical University, Mykolaiv, Ukraine

1. General provisions

This Memorandum of Cooperation (hereinafter referred to as the "Memorandum") defines the relationship and areas of cooperation between The Central-European Academy of Training and Certification (CEASC), Bydgoszcz, Poland, and Pylyp Orlyk International Classical University, Mykolaiv, Ukraine, hereinafter referred to as the Parties.

The Parties sign this Memorandum on the basis that informational, consulting and practical activities in the field of implementation of European standards in the Ukrainian education system are an urgent and multicomponent process and have an important task - to introduce world practices of training specialists in the educational sphere, to share experience in the use of tools to support the mobility of scientists, the development of scientific careers, and the exchange of best practices of the project approach in the organisation of educational institutions.

2. Areas of cooperation between the Parties

2.1. To implement this memorandum, the parties define the following areas of cooperation:

2.1.1. Conducting joint events (seminars, workshops, lectures, conferences, etc.), informational and consulting work among students, teachers, researchers, representatives of the educational environment and institutions to obtain and disseminate international experience in this area;

2.1.2. Development and implementation of educational and information programmes and courses, training programmes for specialists in new specialities in the format of postgraduate education jointly with the Foundation's partners, and various projects aimed at implementing training standards following the European qualification framework to gain the best European practices;

2.1.3. Assist in the establishment of a project office at the Pylyp Orlyk International Classical University as a separate structural unit, which will be responsible for informing about opportunities to participate in international projects, advising on working with European structural funds to raise funds through project activities for the development of educational institutions and the development of the scientific career of representatives of higher education institutions in the region;

2.1.4. Organising consultations with representatives of the academic community and scientists to exchange experience through video conferences and study visits to relevant institutions in the European Union;

2.1.5. Any other forms of cooperation agreed upon by the parties.

3. Mutual obligations

Any activities under this Memorandum on the territory of Ukraine shall be governed by this Memorandum, the laws of Ukraine and other documents agreed upon by the parties. The Parties shall interact on the principles of equality, openness and charity.

The Parties shall cooperate on the implementation of the provisions of this Memorandum through authorised representatives delegated by the Parties to consider current issues and hold joint events.

The parties agree that the terms of this memorandum are not confidential and may be disclosed to interested third parties as necessary.

Unless otherwise agreed, the Parties agree that each of them shall bear its own expenses in relation to the tasks provided for in this memorandum. All amendments to this memorandum shall be executed in writing and upon agreement of the parties.

4. Final provisions

The relationship between the parties outlined in this memorandum is solely that of independent parties. Each party shall have the right to cooperate with a third party on any matters similar to those contemplated by this memorandum. Nothing in this memorandum shall prevent either party from entering into other agreements with other parties.

All disputes concerning the interpretation and application of the provisions of this memorandum will be resolved through diplomatic negotiations and consultations between the parties. This memorandum shall enter into force on the date of its signing. Termination of the memorandum shall take effect three months after receipt of a written

notice by the respective party. Thereafter, the memorandum shall cease to have effect except for the settlement of claims arising prior to the date on which the memorandum ceased to have effect and any ongoing activities on the implementation of specific projects under this memorandum.

The text of the Memorandum is drawn up in two copies in Ukrainian, one copy for each of the parties, and all copies shall be equally valid.
