

## **MEMORANDUM**

on cooperation in the field of education and training between the  
Pylyp Orlyk International Classical University (Ukraine) and the  
International Society of Polygraph Examiners (USA)

Date of signing: 24 May 2019

Date of entry into force: 24 May 2019

The Pylyp Orlyk International Classical University and the International Society of Polygraph Examiners, hereinafter referred to as the Parties, wishing to develop cooperation in the fields of education and science on international standards and principles of psychophysiological research using a polygraph, convinced that cooperation will contribute to a better understanding and closer ties between them, agreed on the following:

### **1. General**

The Memorandum of Cooperation (hereinafter referred to as the "Memorandum") defines the relations and areas of cooperation between the private higher education institution Pylyp Orlyk International Classical University and the professional non-governmental organisation International Society of Polygraph Examiners (hereinafter referred to as ISOPE). The International Society of Polygraph Examiners was established in the United States and unites representatives from more than 22 countries.

The Parties conclude this Memorandum based on the fact that only active cooperation between educational institutions and international professional polygraph NGOs in the world will give a chance to ensure the formation of a modern polygraph profession, standards of polygraph work and scientific research in this area.

This Memorandum is consistent with the goals set by the Parties, but only specifies some of them and defines the areas of cooperation between its signatories for 2019-2024.

Any activities under this Memorandum in Ukraine and the United States will be governed by applicable law. The Parties shall cooperate on the principles of equality, openness and goodwill.

## **2. Areas of cooperation between the Parties**

The parties agreed to cooperate in the following areas and directions:

1. Conducting joint events (seminars, trainings, lectures, conferences, etc.) on premisses of the private higher education institution "Pylyp Orlyk International Classical University" (Ukraine) and outreach activities among cadets, teachers, scientists, lawyers and polygraph examiners, aimed at building a modern polygraph profession, compliance with international standards in the field of psychophysiological detection of hidden information, training and development of polygraph skills.
2. Consultations to develop agreed positions on solving the most pressing and urgent problems in the field of instrumental detection of hidden information, and exchange of experience in organising educational polygraph events.
3. Any other forms of cooperation agreed upon by the Parties.
4. The Parties express their desire to promote professional relations in the field of science and research in the field of instrumental detection of hidden information, based on mutual interests, and may conclude separate agreements on cooperation, etc.
5. The parties will promote cooperation in education, research and science through participation in joint projects.
6. The International Society of Polygraph Examiners will inform the National Academy of Internal Affairs of educational events organised by the International Society of Polygraph Examiners.

The parties will inform each other about available scholarship programmes.

## **3. Conclusions and provisions**

Amendments to this Memorandum of Understanding may be made by mutual agreement of the Parties and will be set out in separate protocols that will be an integral part of this Memorandum.

All disputes concerning the interpretation and application of the provisions of this Memorandum shall be resolved through negotiations and consultations between the Parties.

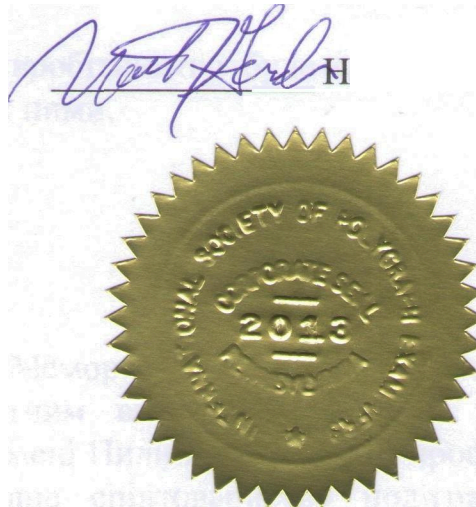
The Memorandum is concluded for five years and shall enter into force on the date of its signing. It shall be automatically renewed for subsequent five-year periods unless one Party notifies the other Party in writing at least one month before the expiry of the relevant period of the Memorandum about the intention to terminate it. This Memorandum does not preclude cooperation in other areas.

Done at Kyiv on 24th May 2019 in duplicate, in the Ukrainian and English languages, both texts being authentic.
